I. Call the Meeting to Order – 7:00 p.m.

The meeting was called to order by the Chair, Susan Dunnell.

II. Committee Chair, Susan Dunnell, opened the meeting with a moment of silence for

III. Special Reports & Presentations

<u>Pre-K-12 Visual Arts: Art Integration:</u> Mike Correa, Mulready teachers Patty Regh and Mary Hall and 2nd grade students Paige Thomason, Chris Walsh, Sara McDowell and David Schwartz presented a model demonstration of a teacher teaching art and math lessons illustrating the integration of art into Science, Technology, Engineering, ARTS, Math.

Teacher Diane Hoff presented a sampling of writing and artwork done by the students as they learned about hibernation.

Teachers Sharon Carloni and Lauren Miller presented a selection of student self-portraits and students' stories about themselves in the role of a superhero.

Committee members congratulated the students, teachers and Mike Correa for their wonderful work and the success of the art integration program.

Superintendent's Award for Academic Excellence: Dr. Lyons announced the recipient of the Superintendent's Award for Excellence is Mark Terra-Salomao. Mark is ranked #1 in the class of 2012. He received the Harvard Book Award in 2011, he is National Honor Society Vice-President this year, and he will complete seven Advanced Placement courses at HHS. He is also a 5-year varsity tennis performer, and serves as Community Council Moderator. He traveled to Portugal last year with the HHS team that presented a paper on Green Chemistry at the UNESCO Conference. He is a regular Portuguese Club Volunteer, a religious education teacher, and has volunteered at the Marlborough Hills Healthcare Center. Mark and his parents were in attendance to receive this award. Mr. and Mrs. Terra-Salomao thanked the Hudson Public Schools and teachers for the education their children have received. Committee members and student representative Ricky Gelin congratulated Mark for his accomplishments.

<u>Procedures for Head Injuries and Concussions</u>: Jenny Gormley, Courtney Cray, Pat Emmons and Angie Wilcox presented the assessment tools and procedures they have developed and implanted for head injuries and concussions. This team has led the District's efforts to develop policies and procedures in compliance with the new state law on head injuries in student activities.

- Race to the Top Grant Approval: Dr. Lyons reported to the Committee that the District's Race to the Top grant application had been approved. This grant will assist in a number of ways, but particularly with educator evaluation and curriculum alignment.
- VI. Committee Chair, Susan Dunnell, then suspended the meeting at 8:31 p.m. in order to conduct a hearing on the FY13 school budget.
- VII. Committee Chair, Susan Dunnell, reconvened the meeting at 9:13 p.m. following the public hearing on the school budget.

Motion was made by Ms. Valcourt to have administration move a .5 ELL teacher position (\$35,595) and funding for PBIS Training (\$5,000) to the designation of Level-Services. Motion was seconded by Mrs. Ducey. On a vote of 7-0, the motion passed.

IX. New Business

1. <u>Approval of School Committee Policy Revision: Assignment to Grades:</u>

Motion to approve was made by Mrs. Ducey and seconded by Mr. Baran. On a vote of 7-0, the motion passed.

Mr. Calnan read the following JCAA Policy Revision for Assignment to Grades into the record:

"In the Hudson Public Schools it is expected that most students will progress from grade to grade, kindergarten through grade 12. There may be instances where promotion from one grade to the next is not in the child's best interest.

Student grade assignment will reflect a careful analysis of all factors involved for consideration for promotion/non-promotion (academic, social, emotional, and physical development), and will always result in what the school considers to be a decision in the best interest of the child.

If retention is considered by the parents/guardian or by the school, the Principal will confer with the parents/guardians, special education staff and other appropriate personnel before making a determination. A student should not be retained in Grades K-8 more than once.

The decision of the Principal is final. Any student not promoted, if not on an Individual Education Plan (IEP), will be referred for special education evaluation."

2. <u>Approval of School Committee Policy: Homeless Students/McKinney-Vento Act</u>:

Mrs. O'Brien described the need for this new policy and informed the Committee that the policy proposed had been posted to the District website for two weeks and circulated to all staff for comment.

Motion to approve a new School Committee Policy: *Homeless Students/McKinney-Vento Act* was made by Mrs. Ducey and seconded by Mr. Baran. On a vote of 7-0, the motion passed.

Reclassification of Funds

None.

Subcommittee and Building Committee Liaison Reports

Dr. Lyons informed the Committee that the first arrival of steel at JFK Middle School is scheduled for January 16th.

Communications

Student representative Ricky Gelin shared with the Committee that discussions on the new HHS schedule are ongoing. He will continue to update the Committee.

Ms. Valcourt reported to the Committee that the recent MASC Bulletin had an article on the MASC sample policy on concussions.

Ms. Valcourt also shared with the Committee actions on MASC 2011 Resolutions. She noted that Resolution No. 1: Providing Greater Access for Student to Exploratory Visit to Chapter 74 Approved Vocational Education Programs was adopted with the amendment that Chapter 74 schools will assume costs.

Mrs. Dunnell shared with the Committee that the registration deadline for the MASC Annual Conference in Boston (April 21-23) is January 31st.

Dr. Lyons circulated a copy of the MSBA Statement of Interest for Mulready Elementary School which was prepared by Director of Facilities, Lenard Belli. Dr. Lyons complimented Mr. Belli's work.

X. Executive Session/Adjournment

At 9:23 p.m., Committee Chair, Mrs. Dunnell, noted that there was not a need for Executive Session.
