I. Call the Meeting to Order – 7:03 p.m.

The meeting was called to order by Committee Chair Michele Tousignant Dufour.

II. Matters for Action:

1. Approval of 3-Year Employment Contract for Dr. Marco Rodrigues to Serve as Superintendent of Schools for the Period Commencing July 1, 2017

Committee Chair, Michele Tousignant Dufour, thanked those in attendance for their support for Dr. Marco Rodrigues as the next educational leader in Hudson.

A motion to approve a 3-year contract for Dr. Marco Rodrigues to serve as Superintendent of Schools for the period commencing July 1, 2017, as presented, was made by Ms. Tousignant Dufour and seconded by Mr. Maston. On a vote of 7-0, the motion passed.

Committee Chair, Michele Tousignant Dufour, invited Dr. Marco Rodrigues to sign the official contract and welcomed him to Hudson Public Schools, and noted that Dr. Rodrigues will be in District during the coming months to begin the transition process.

2. Approval of Contract with Brandon's Dads Productions, Inc. for Use of the Quinn Middle School on May 3, 2017 for Filming Purposes

Committee Chair, Michele Tousignant Dufour, shared that the Town has been approached by the film crew recently filming in Hudson and that they were interesting in filming an exterior shot at the Quinn Middle School.

After a meeting with Dr. Fortuna, Principal Webster and Ms. Tousignant Dufour, the filming will be done at night on Thursday, May 3rd with minimal disruption to the children, no filming crews in the classrooms, and the District will be compensated in the amount of \$15,000.

Discussion ensued.
